Louise's Story

Maybe Louise looks familiar to you, or you've heard of albinism. Louise was diagnosed with Oculocutaneous Albinism Type 1 (OCA). More socially known as albinism, OCA Type 1 is a genetic condition characterized by a lack of pigment in an individual's eyes, skin and hair. Albinism also affects vision. The degree of vision impairment varies with the different types of albinism and many people with albinism are considered "legally blind."

The moment we walked in, we knew it was the place for us

Upon first learning of her diagnosis, Louise's parents, Scot and Megan McMorris, were heartbroken. Questions of, "Will she be able to see?", "Will kids make fun of her?" and "Will she be able to drive?" started overwhelming the family as they envisioned a future for their newborn. When she began attending Anchor Center for Blind Children, her family was filled with "a new sense of normal" in


in the doors at Anchor Center, we knew it was the right place for us," shares Megan. "This was a whole new world for our family. One we were scared of, but open to embracing."

Earlier this year, Megan and Scot posted a video online of Louise trying on her glasses and recognizing her mother for the first time. The next morning, Louise's video had gone viral with over one million views. "We were shocked and immediately bombarded by phone calls from news sources such as Inside Edition, ABC World News and Entertainment Tonight," remembers Megan. The outpouring of support also came from Denver's local news stations as well. "The response to our video was overwhelmingly wonderful." With the spotlight still on Louise after 12 million video views, the McMorris' feel grateful they are able to share their journey with other families who are struggling

with the reality of caring for a young child with albinism or vision impairment.

Anchor Center Welcomes New Executive Director!

For the past 25 years, Heather Cameron has served in leadership positions for an array of nonprofit and governmental organizations, including Laradon, the Center for Nonprofit Excellence, Metro Volunteers, the National Alliance on Mental Illness (NAMI)
Colorado, Mental Health America of Colorado, and Foothills Animal Shelter. On October 12, Heather joined Anchor Center for Blind Children, serving as its new Executive Director.

Helping organizations "move to the next level" has been central to Heather's career. From 1999 to 2001, she facilitated the statewide expansion of NAMI, Colorado's Family-to-Family Program. From 2001 to 2006, she helped spearhead the implementation of the Crisis Intervention Teams (CIT) police training program across Colorado. From 2006 to 2010 she was instrumental in the creation of Colorado's 24/7 crisis line, Metro Crisis Services, now known as Rocky Mountain Crisis Partners. In 2010, Heather joined Foothills Animal Shelter, serving as its executive director during a time of dramatic organizational change. Under her leadership, the Shelter increased earned income by 50 percent, formed a 501c3 supporting organization (the Friends of Foothills Animal Shelter), secured the Division Winner title for the national ASPCA Rachel Ray Challenge, doubled the Shelter's volunteer force, and grew adoption rates by over 15 percent.

Heather is excited to be a part of the Anchor Center team. "Anchor Center has a wonderful mission built and grown by the remarkable passion and dedication of its founders, board members, staff, volunteers, families and donors. For me, leadership is about service to others. I am honored to have this opportunity to serve Anchor Center, to join the Anchor family and community, and to build upon the Center's legacy of inspiration and hope."

"Anchor Center has not only helped our daughter, but has also been a great support system for us as her parents," said Megan.

The McMorris' reflect on the past year and all the awareness their little daughter Louise has generated. "Keeping it in perspective is key. No matter what, it could always be worse. However, I don't know where we would be without Anchor Center. 'We' includes all of the children and parents who benefit from their services. It is because of this place that we have a sense of hope and no longer feel alone in this journey. The staff makes us feel like family and together we are united in the ups and the downs. We are so blessed and know that Louise is going to thrive beyond our wildest dreams."




