Dear Friends,

We are so grateful for your support this year and throughout our nearly 4 decades of history. Little did we know in 1982 – when Anchor Center's services began in the basement of Wellshire Presbyterian Church for 5 children – how significant our impact would be for children with vision impairments and their families. From day one, Anchor Center was, and still remains, a beacon of hope.

As a nationally recognized leader in the field of pediatric blindness, Anchor Center is currently planning a new Cortical Visual Impairment (CVI) initiative that will broaden our scope, to benefit children and families in need, and positively impact research and practice in our growing field.

Cortical Visual Impairment (CVI) is a condition whereby the eyes are healthy, but the brain is unable to interpret visual information. As this unique visual impairment is brain-based, and because the brain grows so exponentially from ages birth to 5, this neuroplasticity allows for growth and rehabilitation. In short, the sooner we identify babies with CVI, the sooner we can intervene to provide services, and create greater progress and outcomes.

This has been a year unlike any other, but Anchor Center continued to serve our children after the March 2020 onset of COVID-19 and the subsequent closure of our education center. Through the help of staff and volunteers, we were able to increase distance learning opportunities through telehealth home visits and consultations. We were able to create virtual skill-based demonstrations such as orientation and mobility as well as feeding and nutritional guidance. We were able to do regular, supportive check-ins. We created online educational resources, and a curbside lending library of classroom supplies, books in braille, assistive technology devices and therapy equipment. And, with the help of generous donors, we were able to establish a Family Resource Aid Fund to help our families with food insecurity and mortgage/rent concerns.

Your support throughout the year helps make everyday miracles happen at Anchor Center. It also creates opportunities, such as this new CVI endeavor, and allows us to respond to any other challenges, like COVID, that may arise. Thank you for continuing on this journey with us.

INFANTS (0-18 months)

Teachers and therapists help caregivers gain understanding of their child's unique vision challenges and strengths; strategies to care for their infant's special needs; and tools to nurture their child's early development.

PRESCHOOLERS (3 - 5 years)

Preschoolers receive individualized early childhood special education via the nationally accredited Expanded Core Curriculum (ECC). Preschool advances instruction in orientation and mobility, literacy and braille, prosocial and

daily living skills, and the use of assistive technology. Preschoolers also enjoy multisensory education through music and horticultural therapies, as well as community field trips and events.

HOME VISITS (0 - 3 years)

Provided in the child's home, our Teachers of Students with Visual Impairments (TSVIs) offer one-to-one vision consultation and training to parents/caregivers and

children. Our TSVIs assist parents in adapting their homes and practicing techniques to promote and nurture infant and early childhood development, exploration and learning.





More than 50% of our students have been diagnosed with CVI, which is a brain-based visual impairment. That means the eyes are healthy, but the brain is not able to interpret visual information. It is the current leading cause of visual impairment in children in the developing world, including the United States, and it often presents with other neurological disorders. 
